



What LLNL and the DOE don't want you to know

- The “Stockpile Stewardship” Program (SSP) going on at Lawrence Livermore National Laboratory (LLNL) and the other weapons labs has already led to at least one new military capability for a nuclear weapon, and is almost certainly adding more capabilities to nukes now.
- Current LLNL programs aim to maintain and increase the ability to design new nuclear weapons, even under the restrictions of the Comprehensive Test Ban Treaty.
- LLNL’s nuclear weapons activities wreak havoc on the environment.

“Stockpile Stewardship” has already added a new military capability to a nuclear weapon.

As part of the misnamed “Stockpile Stewardship” Program, Los Alamos National Lab (LANL), working with the other weapons labs, added earth-penetrating capability to the B61 nuclear bomb in 1996. To find out more, go to www.google.com and search for:

“Stockpile Stewardship” means new and modified nuclear weapons.

The Department of Energy (DOE) Fiscal Year 1997 Stockpile Stewardship and Management (SS&M) Plan reveals the true purpose of the SSP:

“Program Needs....Establish the capability to design a new weapon...[t]he ability to design nuclear weapons is the core of [the] DOE program and is utilized in all other aspects of the program.” If they tell you that the SSP's goal is merely “safety and reliability” of existing nuclear weapons, they are telling you a lie. Copies of the FY 1997 SS&M Plan can be obtained from Tri-Valley CAREs or the DOE.



LLNL’s nuclear weapons activities devastate the environment.

LLNL main site and site 300, its experimental test site in the Altamont Hills, are Superfund cleanup sites. These areas are some of the most polluted in the US, mostly due to nuclear weapons research and development.
