RULES

1. To apply for a gasoline reimbursement for your vehicle, you must be bringing 5 or more people (including driver) to the August Action and driving a minimum of 30 miles to Livermore. Gasoline reimbursement, if awarded, will be calculated at \$3/gallon and figured at the rate of 20 miles per gallon. Total reimbursement may not exceed \$80. Documentation required will include your beginning point, proof of insurance, driver/passengers' full names and contact info (e.g., cell or email). You must apply and receive a positive written response at least ten days prior to driving in order to be eligible for reimbursement.
2. To apply for a van rental reimbursement, you must be bringing 6 or more people (including driver) to the August Action and driving a minimum of 30 or more miles to Livermore. Van rental reimbursement, if awarded, will be figured at the rate (plus tax) documented on your paperwork or \$80, whichever is less. You must supply proof of insurance and apply and receive a positive written response at least 10 days prior to driving in order to be eligible for reimbursement.
3. To apply for a bus rental (or gas to drive a bus) you must provide proof of insurance and make specific arrangements in writing at least 10 days in advance of the event in order to be eligible for reimbursement.
4. All gas or rental reimbursements - whether partial or full - are at the discretion of Tri-Valley CAREs. All arrangements must be in writing and signed by Tri-Valley CAREs. There are no verbal agreements. There is no other contract expressed or implied.
5. All liability for travel and all travel expenses not expressly eligible for reimbursement in writing and signed are the full and sole responsibility of the driver(s) and/or passengers and not Tri-Valley CAREs.
