## **YOUR NUCLEAR WEAPONS UPDATE 2010...**

2010 is well underway, and the coming months hold major opportunities to advocate for changes in U.S. nuclear weapons policy.

Jan 28th - A high level Obama Administration official will be speaking on nuclear weapons issues. The timing is thought to be related to the President's State of the Union address.

Feb 1st – The DOE releases its fiscal year 2011 budget request to Congress (and to us in the public).

March 1st- The Nuclear Posture Review is scheduled to be released. This is the Obama document that can influence U.S. policy for the coming decade.

Between now and March 31st- The “follow on” agreement to START (Strategic Arms Reduction Treaty) with Russia is scheduled to be completed.

May- The nuclear Non-Proliferation Treaty Review Conference will take place at the United Nations in New York City.

Each of these events will come with opportunities for Tri-Valley CAREs and YOU to respond by writing letters to the editor, making calls, and/or taking it to the streets. We will keep you posted with action alerts and more in the coming weeks and months.

## **UPDATES ON NUCLEAR CLEANUP AND BIO-WEAPONS:**

### **Community Meeting on Cleanup of Off-Site Pollutants from Livermore Lab**

Tri-Valley CAREs has long been advocating for a public meeting to involve the Livermore residents whose homes sit atop an off-site plume of contaminated groundwater. Our goal is to ensure that those who are directly impacted by the contamination have an opportunity to participate in decisions that affect their lives.

We had been advised by Lab officials that they would host a public meeting in January 2010. The bad news is that the Lab says it is not “ready” to have that meeting. The good news is that they say the meeting will happen, just not in January. We are following up with Lab officials as well as the state and federal regulatory agencies. Here is our commitment to YOU. If the Lab does not hold a community meeting on the Superfund cleanup in early 2010, WE WILL. Stay tuned.

### **Update on Tri-Valley CAREs' bio-warfare agent research lawsuit**

We received notice from the Northern District Court in early December that our hearing on Cross Motions for Summary Judgment was being continued (moved) from December 8th, 2009 to February 23, 2010 at 1:00pm. Let's keep our fingers crossed that Judge Armstrong is persuaded by our very strong arguments (and our great legal team).
